Conditions of Use and Notes for Guidance

- (1) Each application must be accompanied by the relevant payment. Please make Cheques / Postal Orders payable to Stirling Council.
- (2) The Season Ticket does not guarantee a parking space.
- (3) The Season Ticket will be marked with a zone. Season tickets are available for 3 specific parking areas:

Area D: Albert Place (No's. 19 to 27), Balmoral Place, Clarendon Place, Clarendon Road, Drummond Place, Gladstone Place, Greenwood Avenue, Irvine Place, Melville Terrace (No's 17 to 21), Nelson Place, Park Avenue, Park Terrace, Queen Street, Royal Gardens, Southfield Crescent, Upper Bridge Street, Victoria Place (No's 1 to 17), Victoria Road, Victoria Square, Wallace Street.

Area E: Queens Road, Victoria Place (No's 18 to 67)

Area F: Forthside Car Park, Linden Avenue Car Park

- (4) The Season Ticket entitles the holder to park within the specified area without limit of time and at no additional charge.

It should be noted that parking contrary to the conditions of use for the car parks will lead to an Excess Charge Notice being issued, ie outwith a marked bay or within a reserved bay.

On-street parking within reserved bays, ie disabled or residents will result in a Fixed Penalty Notice being issued.

- (5) The season ticket cannot be used to park in any other area other than the area identified on the season ticket.
- (6) The Season Ticket is invalid if amended or altered in any way.
- (7) Abuse of the Season Ticket system may result in the withdrawal of the Season Ticket.

Permit Renewal Procedure

- (1) Before a Season Ticket will be renewed, payment must be provided
- (2) Applications can be made either in person or by post to Customer First, 1-5 Port Street, Stirling, FK8 2EJ.
